- 2. The self-addressed Business Reply Envelope bears the address of the Scrutinizer appointed by the Company.
- 3. This Ballot Form should be completed and signed by the shareholder. In case of joint holding, this form should be completed and signed (as per the specimen signature registered with the Company / Depository Participants) by the first named shareholder.
- 4. Incomplete and / or unsigned Ballot Form will be rejected.
- Duly completed Ballot Form should reach the Scrutinizer not later than the close of working hours on 08-08-2015. Ballot Form received after this date will be strictly treated as if the reply from the member has not been received.
- 6. The Scrutinizer's decision on the validity of Ballot Form shall be final.
